Grant Application Guidelines

The Wawa, Inc. Corporate Charities Committee accepts and reviews only written proposals throughout the year. Grants are restricted to organizations situated within our geographic focus: ***Delaware, Maryland, New Jersey, Pennsylvania and Virginia.***

Proposals must include the following information:

- Cover letter, which summarizes the project or general request for support, its goals, financial requirements and status. The requested grant amount should be stated.
Note: The % of budget spent on administrative costs must be included in cover letter.
- Brief history of the organization, an annual report, the most recent audited financial statement and a current list of its board members.
- Detailed description of the project, including its objectives, budget, timetable, target population and prospective / definitive funding sources to date. Capital expenses must be documented.
- Resume of project officer and a list of key staff.
- Copy of the most recent Internal Revenue Service letter granting tax-exemption status.

The Corporate Charities Committee meets semi-annually, (spring and fall sessions), to disburse the funds contributed by employees during the year and the matching company contribution.

Applicants generally receive a response within two months of the charities committee meeting; however, applicants may be contacted earlier by committee members to request a telephone conference, site visit, or presentation. Visits to Wawa or contact with its staff by applicants during the proposal review process are discouraged.
